- Maintain technical expertise in work incentives policies, systems, inputs and controls
- Provide technical advice to FO staff
- Provide training to employees and work with management to identify training needs
- Evaluate FO procedures to ensure that both titles are addressed in concurrent cases
- Participate in local outreach activities
- Serve as primary point of contact for local external organizations on work incentives information
